2	Within seven days of announcement of election schedule, Secretary General of Association display the provisional list of all members eligible to vote along with their national tax number, sales-tax-registration number, if applicable, the name and national identity card number and number their representative at notice board of head office and regional offices of the Association and website of Association.	Wednesday 12 <sup>th</sup> July 2017
3	Within seven days of issuance of the voters list, Objections to entries of voters list from member in writing to the Secretary General.	Wednesday 19 <sup>th</sup> July 2017
4	Within five days from receipt of objections, the Secretary General intimate objections or changes, if any.	Monday 24 <sup>th</sup> July 2017
5	Any person/member aggrieved by decision of the secretary general may, within three days of receipt of the decision, make a representative to Election Commission which shall decide the representation within three days.	Thursday 27 <sup>th</sup> July 2017
6	Any person/member aggrieved by decision of Election Commission may file appeal before DGTO within three days of decision of Election Commission.	Tuesday 1 <sup>st</sup> August 2017
7	DGTO shall decide the appeals within 10 days and his decision in this regard shall be final.	Friday 11 <sup>th</sup> August 2017
8	If no appeal filed to DGTO the final list of voters shall be displayed on notice board of head office and regional office of Association and at website of Association within fifteen days of the decision of Election Commission.	Tuesday 15 <sup>th</sup> August 2017
9	Issuance of notice to the Member Inviting Nomination for the Election on vacant seats of executives committee of APGMJA	Friday 18 <sup>th</sup> August 2017
10	Last date of receiving of nominations of papers from the eligible members (as per final list ) (Within four days of the final list of voters and within twenty four hours of receipt of nomination paper a copy of final list of voters shall be provided to each contesting candidate)	Monday 21 <sup>st</sup> August 2017



13	Decision on objections of the candidates by the Election Commission within two days.	Friday 25 <sup>th</sup> August 2017
14	Appeal to the DGTO by any aggrieved candidates against the decision of Election Commission. (D.G.T.O shall give decision within seven days and his decision will be final).	Thursday 31 <sup>th</sup> August 2017
15	Issuance of Final list of candidates for contesting Election for the post of Executive Committee of the Association APGMJA. (Within two days of the decision of Regulator and if no appeal has been made to the Regulator, final list of Candidates shall be issued within eleven days of the decision of Election Commission).	Saturday 2 <sup>th</sup> September 2017
16	Polling for the election of members of the Executive Committee.	Wednesday 6 <sup>th</sup> September 2017
17	Nomination for the election of office bearers from amongst elected executive committee members to be received by Election Commission (Proposed & Seconded by elected executive committee members).(Within two days of the poling)	Friday 8 <sup>th</sup> September 2017
18	Scrutiny of nomination papers of the candidates for election of the office bearers by the Election Commission and its display within twenty four hours of the last date of receipt of nomination papers.	Saturday 9 <sup>th</sup> September 2017
19	Within two days of display of final list of candidates, Polling for election of Office Bearers.	Wednesday 13 <sup>th</sup> September 2017
20	Final Office announcement of election results of members of Executive Committee and office bearers in the Annual General Meeting. (Within fifteen days from the date of polling of office bearer's election.	Monday 18 <sup>th</sup> September 2017
